During the 19th Century, Boulder County, Colorado had 59 school districts, mostly because of the geography of the area. The following books contain the names of more than XXXX students, administrators and parents. These school district census records are valuable genealogical and historical research tools in that they help to establish people in place and time, and establish relationships between children, their parents and their siblings during a critical period when the 1890 census for Colorado does not exist. Males and females were recorded separately, but not always. Names are generally alphabetical. The children are listed by name, followed by their age. The adults are listed by name, followed by their titles in the case of school district employees, or by their relationship to the students—parent, guardian or spouse. In some years, the place where the student was living was included. Towns or sections were included, although full addresses were not. The census is listed as it was written to help maintain hints to relationships where they are not explicitly given. There is an alphabetical index after the census listings.

Students were eligible from age 5 to 25. The diary is alphabetical, but there are no page numbers, so the pages have been given numbers starting with 1 with each new letter in the journal (e.g. A1, A2, A3, etc.). There is more than one handwriting in the journal, which may account for why some districts have the sex of the student recorded, and others do not. Having the sex recorded answers some questions. For example, Bertie and Willie are common names during this time period and are used for males or females. One of the most interesting finds is the number of married women recorded in the census.

The Boulder County, Colorado District Court, Petit Jury Lists, 1883–1910 is an annotated index of the District Court's call for men to serve mostly as petit jurors. There are a few entries for Grand Jurors or Talesmen, essentially an alternate who was available if there were an insufficient number of jurors. There are more than 4,000 entries in this volume. The lists were most likely kept by the Clerk of the District Court, although the clerks are not named anywhere in the volume. Often the record gives the dates that a juror served during the court's term. It is rare for jurors to serve throughout a term. Most jurors served a few days. Some records indicate what the juror was paid for his service. Many records indicate that a juror was "excused for the term," which did not necessarily mean that the person did not serve at all, only that they did not serve for the entire six month term.

The Boulder County, Colorado District Court, Petit Jury Records, 1867-1936 is an annotated index of the District Court's call for men to serve as petit jurors mostly for trials, but occasionally for coroner's inquests. There are more than 20,000 entries during this time period. Often the record gives the place where the juror lives and the miles from his home to the courthouse. Many records indicate that a potential juror was "not a resident," which could mean that the person lived outside of the county (even just across the county line), or that the person was away from home, had moved to a new location within the county or had moved from the area. Some records give specific details as to why the juror cannot be located or cannot serve.

Several special cases are found in this record set, including those investigating "considerable lawlessness especially in the illicit traffic of liquor and gambling," and the Grand Jury statements of May Bradford Oles who was the adopted daughter of Andrew J Macky (a prominent Boulder citizen) and her attempt to claim a part of his large estate.
